**Treasurer's Report**

The Treasurer's report was presented to the Board by Audrey Bauer. Balance on hand as of January 31, 2016 was \$352,591.36

**Chairman's Report:**

Stan Ridgeway informed the board that ambulance rates increased in January, and that assessments may increase as well. The ambulance will now have staff employed from 5am to 5pm to respond during the week. The city will be presenting the increase at their April meeting.

The flashing light on Hwy 10 needs to be properly permitted before it is repaired. Stan is working on the permit process.

The Plan Commission will be meeting on Wednesday February 17 at 6:30pm, and will be discussing a conditional use permit for Monarch Paving to operate a temporary asphalt plant at Kraemer's quarry.
